

# COMMUNITY FIELD – STOUGHTON

## **\$2.00 per car admission for playoffs**

Located Behind the Family Dollar Store on Rte.138 (rear 605 Washington Street) across from Friendly Ice Cream in Shaw's Plaza.

Parking is limited and we try to hold spaces for our visitors. On game day, we ask that Stoughton parents & coaches please park off site and keep the parking spaces open for our guests. **Please note that due to this space limitation, there is a mandatory \$2.00 per car charge** to use the on site parking lot, and this fee is for referees and medical staffing. This is permitted by the League during playoffs & championship play.

However, **you may park at “no charge” at the street side curb only in the strip mall along Washington Street** (please not right in front of the Family Dollar store. Also, do not park on the gravel side of the Family Dollar store either). *Basically, do not park in front of the “Family Dollar store” or the two rows in the center lot in front of the Family Dollar store or you may be towed).*

You can also park at no charge across the street in the **Shaw's parking lot at the curb only** along Washington Street. Stoughton Police will assist you to cross the street. **Phatt Boys Restaurant is now closed so you may also park in their lots “front & back”** and just walk down the street to the field.. **On Sundays only, or after business hours, you may also park at the Rockland Trust Co. across the street.**

### **FROM THE SOUTH:**

ROUTE 24 NORTH – Take exit 18 B (Rte 27N toward Stoughton). Take right at light. Continue on Rte 27N into Stoughton square (3 Miles). Go through the square and bear right onto rte 138N approximately 3/10 mi. Community Field entrance is on the left across from Friendly Ice Cream in Shaw's Plaza and behind the Family Dollar Store.

ROUTE 95 NORTH – Take Exit 8 (South Main Street – Sharon). Take a right toward Sharon where you will merge with rte 27 S and continue all the way through Sharon to the Stoughton Line (approx. 5-mi.). Continue on rte 27 approx. 1.4 mi. to the fork in the road where you will bear left toward rte 24 Randolph/Avon, which is now, Central Street. At the 2nd light, (Washington Street – Rte 138) take a right. Continue 4/10 mi. where Community Field is on the right behind the Family Dollar Store.

### **FROM THE NORTH:**

ROUTE 24 SOUTH – Take exit 20B (Rte 139 Stoughton). Continue all the way to Stoughton square (approx. 3 mi.) where Rte 139 ends. Take a right. Go through the square and bear right onto rte 138N approximately 3/10 mi. Community Field entrance is on the left across from Friendly Ice Cream/Shaw's Plaza and behind the Family Dollar Store.

FROM RTE. 128 – Take Rte 138S toward Stoughton. Follow all the way to Community Field on the right in Stoughton. Community Field is 4/10 mi. after CVS pharmacy. Community Field is on the right behind the Family Dollar Store
